

Prize draw terms and conditions

1. The "Prize Draw" refers to the active travel vouchers available through completing the "Competition". The "Competition" refers to the competition that was being completed and within which included a link to these prize draw terms and conditions.
2. The Prize Draw is open to people aged 18 or over.
3. The Prize Draw is only open to people living in Scotland.
4. Employees or agencies of Energy Saving Trust, Home Energy Scotland or their family members, or anyone else connected with the Prize Draw may not enter the Prize Draw.
5. Entry into the Prize Draw is optional. To enter the Prize Draw you need to complete the Competition and answer the relevant question to opt into the prize draw; including the provision of your name and contact details.
6. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions and agree to the use of their name and contact details to identify them as a winner in the Prize Draw (if applicable).
7. Only one entry per person.
8. The closing date of the Prize Draw is 5pm on 11 August 2021. Entries received outside this time period will not be considered.
9. Three winners will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random computer process. The draw will take place on the date specified within the Competition.
10. The winners will receive one of the Prizes specified within the Competition.
11. The winners will be notified by email on or before the date specified within the Competition; and must confirm their contact details to claim their prize. If a winner does not respond to Energy Saving Trust within 14 days of being notified by Energy Saving Trust, then the winner's prize will be forfeited and Energy Saving Trust shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within 14 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions,

the winner's prize will be forfeited and Energy Saving Trust shall be entitled to select another winner.

12. The prize will be organised for the winners by Energy Saving Trust via email.
13. By entering the Prize Draw, you agree to the collection, retention, usage and distribution of your personal information in order to process and contact you about your Prize Draw entry, and for the purposes outlined in paragraphs 4 and 9 above.
14. By entering the Prize Draw, the prize winners agree to Energy Saving Trust retaining their personal data relating to this competition for seven years to comply with HMRC auditing requirements. After seven years from the date of last contact, Energy Saving Trust will destroy the prize winners' contact details. During this time Energy Saving Trust will not use the prize winners' personal data for anything other than contacting them about their Prize Draw entry, unless otherwise agreed, and for the purposes outlined in paragraphs 4 and 9 above.
15. For all other prize draw entrants, contact details will be retained to measure the success of the competition and advice delivered, unless the entrant has specified otherwise in their selected contact preferences.
16. EST accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered as a result of entering the Prize Draw or accepting/using a prize. Nothing in these Terms and Conditions shall exclude the liability of the Energy Saving Trust under law for fraud or fraudulent misrepresentation, or for death or personal injury resulting from the Energy Saving Trust's negligence.
17. The Prize Draw and these Terms and Conditions will be governed by Scottish law and entrants to the Prize Draw submit to the non-exclusive jurisdiction of the Scottish courts.
18. The prize is non-exchangeable, non-transferable, and is not redeemable for cash or other prizes.
19. Energy Saving Trust's decision is final and no correspondence will be entered into in respect of all matters to do with this promotion.
20. Energy Saving Trust reserves the right to cancel or suspend this competition or to amend the rules at any time without notice, and without any further liability to entrants.

21. No expenses incurred in connection with the Competition will be paid other than as is set out in these terms and conditions.
