

Prize draw terms and conditions

1. The "Prize Draw" refers to the "active travel vouchers" available through engaging with "The competition". The "Competition" refers to the social media campaign that was being engaged with and associated blog post "Journeys to net zero that don't cost the earth" within which included a link to these prize draw terms and conditions.
2. Entry into the Prize Draw is optional. To enter the competition, you need to post your net zero journey pledge on social media and tag "#NetZeroJourney23".
3. The "active travel vouchers" consist of: a one-off payment of up to £2,500 for one winner to be used for an electric bike or cycle, cargo or electric cargo cycle, adapted or electric adapted cycle; and a £100 voucher for [Sustrans' online shop](#) for two runner ups.
 - 3.a. Energy Saving Trust will purchase the cycle on behalf of the winner. The winner must select their preferred cycle option and either submit a link if this is through an online retailer or arrange an invoice to be sent to Energy Saving Trust at sustainabletransport@est.org.uk for payment. Energy Saving Trust will make the payment of up to £2,500. Energy Saving Trust does not guarantee the availability of any preferred cycle.
 - 3.b. If the preferred cycle costs above £2,500 the winner may use their own funds or the eBike Loan for the remainder of the total provided they are eligible and have agreed to the full terms and conditions, which can be accessed [here](#). eBike Loan funding is not guaranteed.
 - 3.c. Energy Saving Trust will purchase the voucher for Sustrans' online shop and send these to the two runner ups by their preferred method.
4. The Prize Draw is open to people aged 18 or over.
5. The Prize Draw is only open to people living in Scotland.
6. Employees or agencies of Energy Saving Trust, Home Energy Scotland or their family members, or anyone else connected with the Prize Draw may not enter the Prize Draw.

7. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions and agree to Energy Saving Trust contacting them through the relevant social media account (Twitter, Facebook or Instagram) to identify them as a winner in the Prize Draw (if applicable).
8. In tagging “#NetZeroJourney23” you agree that Energy Saving Trust may reshare your post for the purposes of promoting the competition. If you do not wish for your post to be reshared, message @HomeEnergyScotland or @HomeEnergyScot to opt out.
9. Only one entry per person.
10. The closing date of the Prize Draw is midnight 31 January 2023. Entries received outside this time period will not be considered.
11. One winner will be chosen from a random draw of entries from social media handles collected in accordance with these Terms and Conditions. The draw will be performed by a random computer process. The draw will take place within 5 working days of the competition closing.
12. The winner will receive the Prize specified within paragraph 2 of these Terms and Conditions.
13. The winner will be notified by social media within 10 working days of the competition closing; and must confirm their preferred contact details to claim their prize. If a winner does not respond to Energy Saving Trust within 14 days of being notified by Energy Saving Trust, then the winner's prize will be forfeited and Energy Saving Trust shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within 14 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and Energy Saving Trust shall be entitled to select another winner.
14. The prize will be organised for the winner by Energy Saving Trust via their preferred contact method.
15. By entering the Prize Draw, you agree to the usage of your social media handle in order to process and contact you about your Prize Draw entry, and for the purposes outlined in these Terms and Conditions

16. For all prize draw entrants, social media handles will be retained to measure the success of the competition unless the entrant has specified otherwise.
17. EST accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered as a result of entering the Prize Draw or accepting/using a prize. Nothing in these Terms and Conditions shall exclude the liability of the Energy Saving Trust under law for fraud or fraudulent misrepresentation, or for death or personal injury resulting from the Energy Saving Trust's negligence.
18. The Prize Draw and these Terms and Conditions will be governed by Scottish law and entrants to the Prize Draw submit to the non-exclusive jurisdiction of the Scottish courts.
19. The prize is non-exchangeable, non-transferable, and is not redeemable for cash or other prizes.
20. EST retains the right to substitute the prize with another prize of similar value in the event the original prize offered is not available, amend these terms and conditions or to withdraw the prizes at any time.
